### From the Pastor's Desk

Dear sisters and brothers in Christ,

I've been thinking quite a bit about prayer. I recently read something that called prayer "the pastor's personal and daily meeting with God." That got me thinking about prayer in a different sort of way. Most of us have schedules filled with tasks and events and meetings of all kinds. It's far too easy for me to think about prayer as something that would be nice to fit into my busy schedule, if I can find the time! The idea of a "meeting with God" helps me think differently about my daily schedule. Each day, I have an important appointment with God. I share that in hopes that it might be a helpful idea for some of you, too. A life of prayer doesn't need to be any more difficult or complicated than getting together with neighbors for coffee, or showing up for a meeting at work.

I use a book with scripture readings for each day and prayers of intercession for the church, for the needs of the world, and for my own ministry and needs. This appointment with God gives me a time each day to pray for everyone on our congregations' prayer list as well as others whose needs I know about but who have not asked to be included on the published prayer list.

Daily prayer doesn't have to involve anything as fancy as my system, though. Martin Luther gives a simple form of daily morning and evening prayer in the *Small Catechism*:

#### The Morning Blessing

In the morning, as soon as you get out of bed, you are to make the sign of the holy cross and say: "God the Father, Son, and Holy Spirit watch over me. Amen."

Then, kneeling or standing, say the Apostles' Creed and the Lord's Prayer. If you wish, you may in addition recite this little prayer as well: "I give thanks to you, heavenly Father, through Jesus Christ your dear Son, that you have protected me through the night from all harm and danger. I ask that you would also protect me today from sin and all evil, so that my life and actions may please you. Into your hands I commend myself: my body, my soul, and all that is mine. Let your holy angel be with me, so that the wicked foe may have no power over me. Amen."

After singing a hymn perhaps (for example, one on the Ten Commandments) or whatever else may serve your devotion, you are to go to your work joyfully.

#### The Evening Blessing

In the evening, when you go to bed, you are to make the sign of the holy cross and say: "God the Father, Son, and Holy Spirit watch over me. Amen."

Then, kneeling or standing, say the Apostles' Creed and the Lord's Prayer. If you wish, you may in addition recite this little prayer as well: "I give thanks to you, heavenly Father, through Jesus Christ your dear Son, that you have graciously protected me today. I ask you to forgive me all my sins, where I have done wrong, and graciously to protect me tonight. Into your hands I commend myself: my body, my soul, and all that is mine. Let your holy angel be with me, so that the wicked foe may have no power over me. Amen." Then you are to go to sleep quickly and cheerfully.

During our daily meetings with God, we can also pray for each other in our congregations. Currently I am preparing a prayer guide for St. Paul's and St. John's that we can all use for daily devotions during the 40 days of Lent, which will include praying for all members of these congregations, as well as other needs of the church, community, and world. I hope
